## Privacy Act 1993 Statement

This information is required to:

( A tenant default database records the names of the persons who have been found in breach of their tenancy agreement and/or the Residential Tenancies Act 1986 by the Tenancy Tribunal);
- This information in this tenancy application form will be retained within our office. If you are not granted a tenancy then this information will be destroyed;
- The information will also be made available to credit bureau and/or tenant default databases and will be accessible to other people that may inquire of this credit bureau and/or tenant default database;
- If you do not supply all the information in this form, you may not be considered for our tenancies
- You have a right to see the information held about you by any credit bureau or tenant default database and to correct that information in accordance with the Privacy Act.
- You need to be aware that we may record conversations while attending our tenancies. This is to enable us to be precise with what is or is not said at any time. This is to assist us with the running of our tenancies. Video recordings of the property may be done during inspections.
